#### ARTICLE I

# Dallastown Borough Community Park [Adopted 8-9-1999 by Ord. No. 444]

## § 139-1. Hours. [Amended 7-9-2007 by Ord. No. 546; 12-10-2007 by Ord. No. 552]

The Dallastown Borough Community Park, located on School Street in the Borough of Dallastown, York County, Pennsylvania, shall be open to the public from 6:00 a.m., prevailing time, until dusk each day. The said park shall therefore be closed from dusk to 6:00 a.m., prevailing time, each day, and no person shall enter said park or be upon its grounds during the hours that it is closed unless so authorized by Dallastown Borough. The hours during which the park is open and closed may be amended from time to time by resolution of the Borough Council.

## § 139-2. Regulations.

- A. The following regulations are hereby established and imposed for the said Dallastown Borough Community Park, and no person shall violate any of the same, to wit:
  - (1) There shall be no littering in the park, and no person shall cause or allow litter to be placed in or upon the grounds of the park.
  - (2) Negligent or deliberate destruction or removal of natural or physical property of or located in the park is forbidden.
  - (3) Any pet brought into the park shall be on a leash and under the control of its owner or handler at all times. The owner or handler of the pet shall immediately and properly remove and dispose of any and all feces left by the pet. [Amended 7-9-2007 by Ord. No. 546]

- (4) No metal detectors are allowed in the park. [Amended 7-9-2007 by Ord. No. 546]
- (5) No glass containers are allowed in the park.
- B. The following regulations are hereby established and imposed for the said Dallastown Borough Community Park, and all persons shall obey the same unless otherwise authorized in advance by Dallastown Borough, to wit:
  - (1) No fireworks, guns,, rifles,, airguns, bows, slingshots, paint ball guns or any similar items are allowed in the park.
  - (2) No motorized vehicles shall be permitted inside the fenced area of the park.
  - (3) No pets are allowed in the park.
  - (4) No bicycles, skateboards or metal detectors are allowed in the park.
  - (5) No solicitation is allowed in the park unless by prior arrangement during an approved event.

## § 139-3. Open fires and hot coals; cooking fires.

No person shall ignite or feed an open fire or hot coals in or upon the grounds of the said Dallastown Borough Community Park nor cause or allow the maintenance of any open fire or hot coals in or upon the grounds of the said Dallastown Borough Community Park. Notwithstanding the foregoing, a fire for cooking purposes only is allowed in fireplaces or grills provided for the same in the said park, but in such event no such cooking fire shall be left unattended, and such fire shall be thoroughly extinguished before being abandoned.

### § 139-4. Definitions.

As used in this article, the following terms shall have the meanings indicated:

PERSON — Any natural person, corporation, partnership, firm, association or other entity.

## § 139-5. Violations and penalties.

Any person, corporation, partnership, company, firm, association or other entity who shall violate the provisions of this article shall, upon conviction thereof, be sentenced to pay a fine of not less than \$50 nor more than \$600, together with the costs of prosecution, and, in default thereof, be sentenced to imprisonment in the York County Prison for a period of not more than 30 days.
