- Mr. Blanchard stores used mowers and snow blowers in his garage at 42 E Frederick St. Mr. Blanchard let Council know that he rents a space in Red Lion for his repair shop, where he repairs and sells his mower & snow blowers. In 2021 Mr. Blanchard was sent a violation letter stating he was in violation of the zoning ordinance. After discussions with Mr. Garabedian, zoning officer at the time, he ceased repairing engines in his garage. Since then, Mr. Garabedian has received numerous complaints regarding the property still being used as an illegal business. Since there is only storing and removal of equipment, engines, etc., it was found that Mr. Blanchard was not violating any ordinances. Mr. Blanchard was notified that blocking the alleyway is a PA vehicle code and that the police will respond to these types of violations.
- Mr. & Mrs. Gemmill at 450 E Market Ave feel that their neighbor Mr. Blanchard is running a small engine repair shop out of his house at 42 E Frederick St. Mr. & Mrs. Gemmill have pictures of Mr. Blanchard storing mowers and snow blowers in his garage, as well as him blocking the alley to unload and load equipment. Attorney Ruth let the Gemmill's know the Borough doesn't legally have the option to make Mr. Blanchard not be able to store equipment in his own garage. As for him blocking the alley, Attorney Ruth suggested they call the police.
- Pastor McKinnie, from the Truth Tabernacle Seventh-Day Adventist Church located at 205 W Main St., wanted to invite Council to their grand opening this Saturday October 14<sup>th</sup> at noon. They will have a service at noon and some special guests will be there.
