#### **ENGINEER'S REPORT**

The Engineer's report was given by the Borough Engineer Steve Malesker.

- Mr. Malesker stated that Mr. Rehab had reached out to him in regards to the contract that was awarded to them last month for the sewer maintenance program. The original completion date was set for September of this year, but Mr. Rehab had reached out stating they will not be able to begin the work until October or November. Mr. Malesker said Mr. Rehab will need to issue a no-cost change order to extend their contract time. Mr. Malesker does not believe it is worth taking back the award and going with Pipe Services as the cost will stay the same and Pipe Services bid came in around \$20,000 more than Mr. Rehabs'. Mr. Malesker recommends that the Borough keep their initial award with Mr. Rehab and accept their no-cost change order when it come in September.
- The letters for the Colonial Heights basement surveys were sent out a month ago. Joe Joines had sent out a completed survey to Mr. Malesker. Connie Stokes stated that Mr. Joines has already completed more than half of the basement surveys at this time. Mr. Malesker expressed the need for the surveys to be done before the engineering of the sewer project can be done.
