# **ENGINEER'S REPORT**

- Mid Atlantic Storage has started repairs on the new Park St. Tank. Repairs should be completed around April 11<sup>th</sup> and need to cure for 21–30-days. The tank should be back in service around mid-May.
- HRG is waiting for a revised plan from the Developer of the Heather Glen development on Yoe Drive. This
  development consists of 58 high density residential lots to finish Heather Glen Drive. The homes will be built by
  Burkentine Builders.
- HRG provided the program guides for the CFA PA Small Water and Sewer Grant. DYWA agreed on combining
  two projects for this Grant; replacing 700ft of galvanized main on E. Howard St. in Yoe and replacing 1200ft of
  lead main on Mockingbird Drive in Dallastown. With approval, HRG will write and submit the grant for DYWA.
   Motion: Mrs. Sprague moved and was seconded by Mr. Callahan to authorize Authority Chair, Patricia Myers, to
  execute the application for the grant.

# **SOLICITOR'S REPORT**

- Burkentine Builders has asked DYWA to take dedication of the water infrastructure in the finished section of Hudson Ridge. Mr. Joines has given them a list of repairs that need to be completed before accepting the dedication.
- Mr. Ruth announced that as of March 31, 2025, Stock and Leader no longer exists. They are now part of Saxton and Stump. Mr. Ruth will continue to work out of the York office, and his rates will remain the same under Saxton and Stump. Mr. Ruth has an engagement and client election letter that needs approval if DYWA would like to retain Mr. Ruth as the authority's solicitor, now with Saxton and Stump.

**Motion:** Mr. Malesker moved and was seconded by Mrs. Sprague to keep Mr. Ruth as DYWA Solicitor with Saxton and Stump.

- The tank levels have been good.
- Mr. Joines received a quote from Keystone Engineering to update the SCADA system that communicates reads
  and tank levels. The current SCADA system is outdated and has not been working properly. He recommends
  replacing the SCADA packs at Hardees and Sheetz. The cost would be around \$10,000.

and Sheetz. **Moved:** 5-0
