ENGINEER'S REPORT

- The Park St. tank has been filled, the water has been tested, and the tank is back in service. Mid Atlantic would like to do a 1-year inspection in 2026.
- HRG received the revised plans from the Developer of the Heather Glen development on Yoe Drive. The plans are currently under review.
- HRG submitted the application for the CFA PA Small Water and Sewer Grant. The project consists of replacing 700ft of galvanized main on E Howard St in Yoe and replacing 1200 ft of lead main on Mockingbird Dr in Dallastown. The amount request was \$419,020. HRG looks for the grant to be awarded in early 2026.

SOLICITOR REPORT

- Burkentine Builders has asked DYWA to take dedication of the water infrastructure in the finished section of Hudson Ridge. Mr. Joines had given them a list of repairs that needed to be completed before DYWA would accept the dedication. Burkentine is still working on the punch list.
