ENGINEER'S REPORT

- DYWA received the DEP Water Supply Permit Amendment needed for the Hardees Interconnect. All requested information has been submitted for the CFA Grant; recipients should be announced in July or August.
- The DEP Public Water Supply Permit Amendment needed to install mixers at the Park St. was issued. I.K. Stoltzfus has the mixer to install. He will coordinate with Mr. Joines on the installation date. Mr. Medinsky and DYWA will need to sign off on a post construction certification once the mixer is installed; this will be sent to DEP for testing.
- HRG provided information regarding the Hydraulic Model. HRG had pressure testing loggers in both interconnects. They have about 3 weeks of steady data post hydrant flushing. Stacey will download the data collected and meet with Mr. Joines and DYWA staff to go over information, and she will confirm what DYWA is looking for in the hydraulic model as far as fire protection, tank turnover, drafting etc. HRG would like to make a formal presentation with all the findings at the next DYWA meeting.
- There are no updates regarding Inch & Co.'s plan to sub-divide/develop land at 70 S. Franklin St.
