- Mrs. Hartz is continuing to work on the Hydraulic model. Mrs. Hartz, Mr. Mendinsky and Joe Joines met to
 discuss some discrepancies between what the water model is showing and the field collected data. Mrs. Hartz
 and Mr. Mendinsky have asked DYWA Maintenance staff to confirm all dimensions, pipe materials and any
 replacement projects match the Authority's GIS System used to create the model. Staff were also asked to
 confirm that all valves are fully open at select locations.
- HRG completed the FAA filing for the Verizon equipment on the Denton St. tank, responses from FAA normally take 1-2 months.

Pleasant is going up for Sheriffs Sale in October, and once sold, the service line must be split to avoid any problems with future shutoffs.
