- The draft of Verizon's lease agreement for the Lions Park Tank was received and reviewed. They added a few items that Attorney Jones wanted to review with the Authority.
  - 1. They agreed to pay \$1300.00 monthly to occupy the tank.
  - 2. If the Lions Club terminates their lease, then the Authority's lease will also be terminated. Attorney Jones is adding that all of their equipment would need to be removed from the tank at that point.
  - 3. Right of First Refusal If a new competitor approaches the Authority to lease tank space, Verizon will pay whatever the competitor was offering to pay in order to keep them off the tank. This does not apply to any existing competitor's lease.
  - 4. Rights upon Sale The Authority would need to make Verizon aware if the tank is sold.
  - 5. The drawings must be received prior to the Authority's approval.
