He also stated that the Authority would fall under strict scrutiny and would set a precedence if leniency would be granted. All customers are treated the same following the rules and regulations set by the Authority. He also explained that the \$15.00 and \$35.00 are charged in order to cover the cost of the shut off notices and posting notices.
 - The Authority agreed with the advisement of Attorney Ruth and denied Mr. & Mrs. Boyle's request.
- Trey Elrod from Gordon Brown Associates was representing the proposed Cape Horn Crossing behind Sheetz on Lombard Road. Plans were presented to the Authority. A 6 foot main was proposed around the property. They would like to dedicate the water line and provide a blanket easement for all utilities. The curb stops can be put wherever the Authority would choose.
 - Mr. Sarpen had made some written comments on the proposal which will be taken into consideration.
