ENGINEER'S REPORT

- Nothing new on Cape Horn Crossing & Hudson Ridge.
- Still waiting on word from DEP on the permit application for the tanks.
- Mr. Kehew spoke to Brian Hyde, a representative from Mid Atlantic storage, concerning the progress on the Park St. tank. Mr. Kehew mentioned to him about having a temporary construction easement in order to keep the small tank in service while constructing the new tank. Mr. Hyde was concerned with having room for construction of the new tank and also access. It would need to be a heavy duty temporary access road in order to support construction vehicles. Mr. Malesker stated any construction entrance would need to be stone so it would not matter where it was located. He also thought it was critical to have the water available and if need be Borough Maintenance can construct the road if necessary.

The estimated time frame for the tank is to begin early March and could take 9 months to build.

GTA, the company that did the soil testing, offered to do the geotechnical engineering study. Mr. Malesker thought it would be easier to have it included into the construction contract.

• The Main St. project is out for rebid. Bids are due prior to the October meeting. The Authority is hoping for a more competitive price.

SOLICITOR'S REPORT

- Waiting on decision from the Judge in regards to Emergency Connection Agreement.
- Sam Snyder from Yoe Borough requested supporting documentation from the Authority concerning administration and labor fees.
- No updates on the Verizon and AT&T leases.
- T-Mobile would like to do a lease renewal for 10 years. The current lease does not expire until 2023. Attorney Ruth will continue to renegotiate.
